SHIPPING INSTRUCTIONS

SENDING FORMS AND PAYMENTS:

- Send your completed entry forms, indicating your choice of payment method, to the Competition office:
BY FAX: +1 (415) 345-9090
BY E-MAIL: info@nywscmp.com
- The entry fee is \$110 per wine entered, and \$425 per spirits product entered.
- Entry fees may be paid by credit card or bank wire transfer by checking the appropriate box on the entry form.
- If you prefer to pay by check, or if you require bank wire instructions, please contact the Competition office at **+1 (415) 345-9000** or send an e-mail to **info@nywscmp.com**.
- Keep a copy of your completed entry form(s) for your records.

SHIPPING WINES AND SPIRITS FROM WITHIN THE U.S.:

- Carefully pack the required number of bottles
WINE ENTRIES: Send **THREE (3) 750 ml bottles** per wine entry
SPIRITS ENTRIES: Send **TWO (2) 750 ml bottles** per spirits entry
- Include a copy of your completed entry form(s) in your shipment.
- Write on the boxes:
"SAMPLE MATERIALS, NOT FOR RESALE. GLASS ENCLOSED."
- For shipments of more than one box, mark each box:
"BOX 1 OF 4," "BOX 2 OF 4," etc.

SHIPPING WINES AND SPIRITS FROM OUTSIDE THE U.S.:

DO NOT SEND ENTRY FEES
WITH YOUR WINES OR SPIRITS
SEE ABOVE FOR PAYMENT INSTRUCTIONS

- You must send **THREE (3) 750 ml bottles** per wine entry, and **TWO (2) 750 ml bottles** per spirits entry.
- If you are using your U.S. importer, they should follow the above instructions for domestic shipping.
- **If you are NOT using your own U.S. importer, you MUST contact the Competition's import partner, Park Street Imports LLC, to avoid shipping delays and unnecessary customs charges.**

Park Street will assist you in obtaining all necessary import documentation and supply you with detailed instructions for properly preparing and labeling your shipment.

WE RECOMMEND THAT YOU CONTACT PARK STREET NO LATER THAN
MONDAY, JULY 16, 2018
TO ENSURE THAT YOUR WINES ARRIVE IN TIME FOR JUDGING.
